ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

To provide a place of worship according to the Constitution and By-laws already set in place and to do any lawful business for this assembly -- "In order to establish or work on a more efficient and permanent basis, we, the members of the Calvary Apostolic Church of Wildwood, Florida, affirm our belief that God's people should be scrupulously set in order, and that it is needful for them to be efficiently organized to successfully carry on the gospel work and properly handle their business affairs."

"The main purpose of this constitution is to provide rules to govern the assembly, according to the scriptures, so that we may advance in the will of God. We mean to maintain a church for the worship of Almighty God and to help spread the gospel of Jesus Christ everywhere."

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The Pastor shall be chosen by the Church Board (deacons) and Assembly by two-thirds majority vote of members present and voting by secret ballot, in a business meeting called for that purpose.
