Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST:

Amendments adopted:

Article II

Principal Place of Business and Mailing Address - shall be amended as follows:

The principal place of business and mailing address of this corporation shall be: 13500 SW 88th St. Suite 285-C, Miami, FL 33186.

Article III Purpose – shall be amended as follows:

The specific purposes for which the corporation is organized is to establish a congregation of believers in Jesus Christ from among the Hispanic community of West Kendall, Miami, FL and to proclaim the gospel message of Christ throughout the world. The corporation will establish and maintain other religious ministries for the sake of the congregation and the community as these needs become evident to the directors of the corporation.

The purposes for which the corporation is organized are exclusively religious, charitable, literary and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Article VIII (New Article) Tax Exempt Activities

Notwithstanding any other provision of these articles, this organization shall not carry on any activities nor permitted to be carried on by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Article IX (New Article) Dissolution

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction, in the county in which the principal office of the organization is then located, exclusively for such purposes.

SECOND: The date of adoption of the amendments was October 13, 2002

THIRD: These amendments were adopted by the members of Iglesia Cristiana en West Kendalland the number of votes cast for the amendment was sufficient for approval.
