**ARTICLE I. CORPORATE NAME**

The name of this corporation is THE REBORN APOSTOLIC MINISTRIES INTERNATIONAL, INC..

**ARTICLE II. PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation is 1200 N. W. 29<sup>th</sup> way, Fort Lauderdale, Florida 33311.

**ARTICLE III. PURPOSE OF CORPORATION**

The purpose for which this corporation is organized is to promote the teaching of the Lord, and good will to all mankind. To establish and maintain a place of worship. To unite a people of like faith in the bonds of brotherly love and fellowship. To meet together to worship God in Spirit and truth. To point the lost to the way of life by publishing at home and abroad the true plan of salvation. To provide Christian rules of conduct. Based upon the bible. To foster an appreciation and love for God through lectures, seminars, study groups, exhibits, conferences, camp meetings, the printed page and any and all other appropriate means. 

