I, the undersigned, desiring to associate for the purpose of forming a corporation not for profit under the provisions of Chapter 617, Florida Statutes, do hereby agree to the following:

ARTICLE I - NAME AND LOCATION

The name of this corporation of **DIVINE LIGHT CENTER CHURCH, INC.**, of 980 Lakeshore Dr., Deltona, Florida, 32725.

ARTICLE II - PURPOSES

This is a nonprofit corporation organized for the purpose of Operating an independent church of Religious Science and serving as a spiritual Development center, to aid in the healing of the separation between man and God by making available the knowledge and practices of Science of Mind and other New Thought teachings to all people, especially its members. Further, the purposes of the Church are to foster the spiritual, cultural, and general well being, of its members and to provide facilities for education, fellowship, and public worship. This church shall in no way be active in carrying on propaganda, nor in any other manner attempt to influence legislation or other political activities.

ARTICLE III - DURATION

This corporation shall have perpetual existence.

ARTICLE IV - NONSTOCK CORPORATION

This corporation shall be nonstock, and no dividends or pecuniary profits shall be declared or paid to the members thereof.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 309 Rachelle Ave., Apt. #616, Sanford, Florida, 32771, and the name of the initial registered agent of this corporation is **THOMAS GORDY**.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be increased from time to time, but shall never be less than one (1). The method of election of the directors shall be in the manner as set forth in the Bylaws.

ARTICLE VII - INCORPORATOR

ARTICLE VIII - MEMBERSHIP

The qualification of members and the manner of their admission shall be determined

by the Bylaws of this corporation.

ARTICLE IX - AMENDMENT

The Bylaws and Articles of Incorporation shall be made, altered, amended or rescinded by a majority vote of the members of this corporation present and voting at a regular, annual or special meeting called for that purpose.

ARTICLE X - DISSOLUTION

In the event of dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation and costs of such dissolution shall be distributed to organizations which have qualified for exemption under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or shall be distributed to the Federal, State or local government for a public purpose.

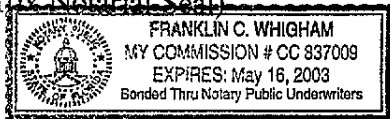

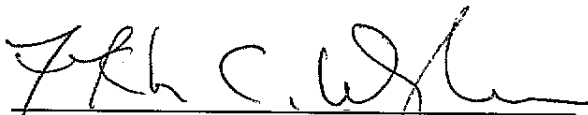
