**Articles of Incorporation
For
ParaServe, Inc.
(A Not For Profit Organization)**

Article I. Name

The name of the corporation shall be *ParaServe*, as designated and named by its founder and Executive Director.

Article II. Principal Office

Section A.

The principal place of business of this corporation shall be:

Article III. Purpose(s)

Section A:

Said corporation, *ParaServe, Inc.* is formed, organized and operates only for religious, charitable and educational purposes according to and in agreement with Section 501© (3) of the Internal Revenue Code. No substantial part of the corporation's activities shall consist of lobbying and the corporation will not participate in any political campaign activities on behalf of any candidate.

Section B:

ParaServe, Inc. purpose is to ensure the safety and protection of communities through the use of education, training, information, resources and equipment to include, but not limited to:

- a) informing and educating economically disadvantaged person's on the dangers of inadequate fire safety measures and precautions in their home.
- b) training economically disadvantaged person's on the use and care of fire safety equipment, specifically smoke detectors/alarms and fire extinguishers.
- c) providing smoke detectors/alarms and fire extinguishers to economically disadvantaged persons at a very nominal costs (not to exceed \$10.00 per family).

- d) providing annual inspections, as required by law to the economically disadvantaged to ensure the proficiency and safety of equipment. This service will also be provided at a nominal cost (not to exceed \$10.00 per family).

Section C:

No part of the net earnings of the organization shall be for the benefit of, or be distributable to its members, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the clause herein.

Section D:

Upon the dissolution of *ParaServe, Inc.* and the subsequent payment of all debts, no part of the remaining assets will be distributed to any officer, member or executive member of *ParaServe, Inc.* In the event of remaining assets, these funds shall be distributed to another organization exempt under the provisions of Section 501©(3) of the Internal revenue Code, or to the United States, or to a state or local government for a public purpose. Any other assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principle office of the corporation is then located.

Article IV. Manner of Election of Directors

The manner in which the directors are appointed shall be determined by the founder and Executive Director and that determination is set forth herein to include:

- a) the Executive Director as Eddie C. Paramore, Sr.
- b) the appointment of no less than three and no more than five members to serve a term of one year on *ParaServe, Inc.* Board of Directors.
- c) the one year tenure of each Board member may be extended for a period of up to two years at the discretion of the Executive Director.
- d) the appointment of members to the Board will be based on the individual's ability to contribute in terms of providing suggestions, information, partnerships and other qualifications as deemed appropriate and necessary by the Executive Director.
- e) the understanding of each appointed member that their services are in an appointed capacity and that they may be terminated at any time without written or verbal advance notification by the Executive Director.
- f) the understanding of each Board member that their position on *ParaServe Inc.* Board of Directors is in an advisory capacity for the promotion, maintenance and sustaining of the corporation.
- g) the filling of vacancies will be made by appointment by the Executive Director.
- h) decisions that are requested of the Board by the Executive Director will be made by a majority vote and provided to the Executive Director as a recommendation.

- i) the creation of committees shall be made at the discretion of the Executive Director to meet the needs and purpose(s) of the corporation. Composition of said committees shall not be limited to the *ParaServe, Inc.* Board of Directors.
