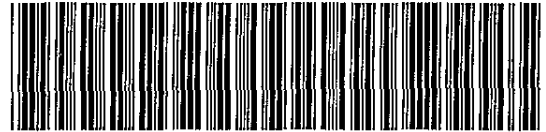



Pursuant to the provision of section 617.1006, Florida Statutes, the undersigned Florida Non-Profit Corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: The following amendment was adopted and added to the Articles of Incorporation:

ARTICLES X
DISSOLUTION

(a) : Upon the dissolution of the Ministry, the Board of Directors shall, after the payment of all the liabilities of the Ministry, dispose of all of the assets of the Ministry exclusively for the purposes of the Ministry in such manner, or to such organization or organizations organized and operated exclusively for the purposes of the Ministry in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall qualify as an exempt corporation or organization under Section 501 (c) (3) of the Internal Revenue Code of 1986, as amended (or of the corresponding provisions of any future United States Revenue Law)


(b) : No part of the net earnings of the Ministry shall inure to the benefit of, or be distributable to, its members, officers, directors, or any person except that the Ministry shall be authorized and empowered to pay reasonable compensation for services rendered, and to make payments in the furtherance of the Ministry. Notwithstanding any other provisions of these Articles of Incorporation or the Bylaws of the Ministry, the Ministry shall not carry on any activity not permitted to be carried on :

(a): by a corporation exempt from Federal Income Tax, under Section 501 (c) (3) of the Internal Revenue Code of 1986, as amended, (or by the corresponding section of any future Revenue Code of the United States of America) or

(b): by a corporation, contributions of which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1986, as amended (or the corresponding section of any future United States Revenue Law).

SECOND : The date of adoption of the amendment was Monday, March 3rd of 2003.

THIRD : The amendment was adopted by the members and the number of votes cast for the amendment was sufficient for approval.
