ARTICLES OF INCORPORATION
OF

A FLORIDA NONPROFIT CORPORATION

The undersigned, acting as incorporators of a Corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be: **FLORIDA PANHANDLE SADDLE CLUB, INC..**

The principal place of business of this corporation shall be: Rt. 1 Box 21, Altha, Florida 32421.

ARTICLE II

The period of the duration of this corporation is perpetually, unless dissolved according to law.

ARTICLE III

The purposes for which the corporation is organized are:

(a) The specific and primary purpose of which this corporation is formed is to provide an organization which provides rodeo activities to the people of the surrounding counties and to promote the safety of said activities.

(b) The general purposes for which this corporation is formed are to operate exclusively for such purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Code.

©) This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

ARTICLE IV.

The qualifications for members and the manner of their admission are:

(a) The corporation shall have a membership distinct from the board of trustees. The authorized number and qualification of the members of the corporation, the manner of their admission, the different classes of membership, if any, the property, voting and other rights and privileges of members, and their liability for dues and assessments and the method of collection thereof, shall be set forth in the bylaws.

ARTICLE V.

The number constituting the initial Board of directors of the corporation is five (5), and the names and addresses of the persons who are to serve initially are:

Said directors to be appointed annually by the President of the Corporation.

ARTICLE VI

This corporation is organized under a non-stock basis.

ARTICLE VII

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal, State, or Local Government for exclusive public purpose.

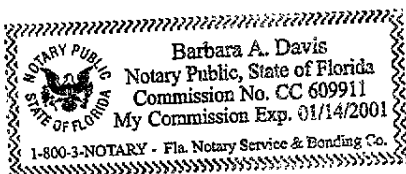
