**ARTICLES OF INCORPORATION**  
**of**  
**BEYOND TOLERANCE, INCORPORATED**  
**A Florida Nonprofit Corporation**

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

**ARTICLE I**  
**Name**

The name of the corporation shall be Beyond Tolerance, Incorporated.

**ARTICLE II**  
**Principal place of business and mailing address**

The principal place of business and mailing address of this corporation shall be:  
5 Patricia Avenue  
Dunedin, FL 34698-8102

**ARTICLE III**  
**Purpose**

Said corporation is organized exclusively for religious, charitable, and educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, and including for such purpose to foster effective community building among diverse religious, racial/ethnic and socioeconomic groups and to encourage positive responses toward full inclusive community.

**ARTICLE IV**  
**Manner of election of directors**

The directors of the corporation shall be elected or appointed as determined in the by-laws of the corporation.

**ARTICLE V**  
**Limitation of powers**

No part of the earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered

and to make payments and distributions in furtherance of its purposes set forth in these articles. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation. The corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the corporation, the board of directors shall, after paying or making provision for payment of all liabilities of the corporation, dispose of all assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational or religious purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future tax code, as the board of directors shall determine. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such charitable purposes.
