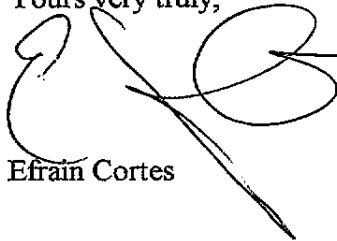

ARTICLES OF INCORPORATION
OF
NEW ASSEMBLY OF GALILEE BAPTIST CHURCH, INC.

ARTICLE I - NAME AND ADDRESS

The name of this corporation shall be **NEW ASSEMBLY OF GALILEE BAPTIST CHURCH, INC.**, with its place of business at 1238 N.E. 6th Avenue, Fort Lauderdale, Broward County, Florida 33304.

ARTICLE II - ENABLING LAW

This corporation is organized pursuant to the Corporations Not For Profit Law of the State of Florida, set forth in Part One of Chapter 617 of the **Florida Statutes**.

ARTICLE III - PURPOSES

(a) To promote the belief in God and Christianity and to engage in any business consistent with the corporations not for profit laws of Florida.

(b) This corporation shall have and exercise all rights and powers conferred upon corporations under the laws of the State of Florida, provided, however, that this corporation is not empowered to engage in any activity that in itself is not in furtherance of its purpose as set forth in subparagraph (a) of this article.

(c) This corporation is organized and operated exclusively for the above state purposes, and not part of any net earnings shall inure to the benefit of any private member.

(d) The activities of this organization are inclusive but not limited to:

1. General Worship Services
2. Christian Education
3. Sunday School
4. Youth Fellowship
5. Weekly Bible Studies

6. Ordination and Installation of Ministries
7. Baptism in Water

ARTICLE IV - TERM

This corporation shall have a perpetual existence.

ARTICLE VII - MANAGEMENT OF CORPORATE AFFAIRS

(a) Board of Directors. The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of no less than three (3) directors. The number of directors shall always be an odd number; but not less than three (3). The number of directors herein provided for may be changed by a bylaw duly adopted by the members entitled to vote. Directors shall be elected annually by majority vote of the membership. The board of directors shall consist of a President, Secretary/Treasurer and Counselor.

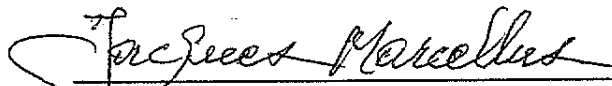
