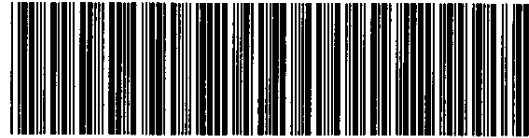

Article I - Name: This body shall be known as Disciples of Faith Outreach Ministry, Inc.  
Jacksonville, Florida, using the facilities located at 7941 Nevada Street.

Article V-Covenant: We, the members of Disciples of Faith Outreach Ministry, Inc.,  
Jacksonville Florida, having been led as we believe, by the Spirit of God, to receive the  
Lord Jesus Christ as our Savior, and on the profession of our faith, having been  
baptized by immersion in the name of the Father, Son, and Holy Spirit, do now,  
in the presence of God and this assembly, enter into a covenant with each other, as  
one body in Christ. We, therefore, agree, by the help of the Holy Spirit and with the  
Bible, the inspired Word of God as our guide, to walk together in Christian love;  
to strive for the advancement of this church; to promote spiritually; to sustain its  
worship, discipline and doctrine; to observe the church ordinances of believer's  
baptism and the Lord's Supper as authorized by our local church; to contribute  
cheerfully and regularly of God's tithes and our offerings to the support of the  
ministry of our church and to the spread of the gospel to all nations. We agree  
to encourage personal and family devotions; to educate our children according to our  
faith; to seek the salvation of the unbeliever; to be just in our dealings, reliable in our  
responsibilities, and an example to those around us; to abstain from the sale and use of  
substances harmful to our bodies, which are the temples of God; to use our influence to  
combat the abuse of all such harmful substances; and to work untiringly for the  
advancement of the kingdom of our Savior by witnessing in words and actions. We  
agree to walk in Christian harmony and watchfulness, giving and receiving assistance  
with meekness and affection; to pray for one another; to help each other in sickness  
and sorrow; to be slow to get angry; to always be eager for reconciliation, seeking it

without delay. We further agree that, when we move from this area we will as soon as possible unite with some other church where we can carry out the spirit of this covenant and the principles of God's Word.

Article VI- Amendments: Changes in this constitution may be made at any regular business meeting, and that written copies have been made available in the church office to the church membership.

Article VII- Adoption: Section 1- This constitution shall be considered adopted and in immediate effect, when members of the board have met and voted. Section 2- A copy of this constitution and bylaws shall at all times be kept by the church clerk and another copy shall be in the church office. All amendments and revisions shall, after the officers of the board meets, be prepared by the church secretary and incorporated in the constitution and bylaws and made available to church members on request. Responsibilities of all committees will be developed and these duties will be formed into a booklet and made available to all church members.

Church Bylaws: Article I- Membership- Section 2. Voting Rights of Members- There will be no voting by members of the church, unless the option is given by the officers of the board.

Article II- Church Staff and Officers: (New Paragraph) Any officer or member of an elected office or committee will be terminated due to misconduct or any act considered unbecoming as prescribed in the Word of God and standards of this church. 1 Peter 1:16 for it is written "be holy, because I am holy."

Article III- Church Employment: All positions will be appointed by the Pastor and the First Lady, with advisement from the from the pastoral staff and officers of the board.

Article IV- Church Meetings: Section 1. Worship services- The church shall meet regularly each Sunday morning, Wednesday evening for Bible Study, and Friday evening for Joy Night. These meetings will be open to everyone and shall be conducted under the direction of the Pastor. Exceptions can be made by recommendation of the deacons.

Article VI- Program Organizations: All program organizations of the church shall be under the Pastor and First Lady control, all officers being selected by the Pastor and First Lady and reporting regularly to them.
