ARTICLES OF INCORPORATION OF SHERATON PLAZA HOMEOWNERS ASSOCIATION, INC

ARTICLE I – NAME

The name of this corporation is SHERATON PLAZA HOMEOWNERS ASSOCIATION, INC. The address of said Corporation is 2905 Langston Drive, Fort Pierce, Florida 34946.

ARTICLE II – CORPORATION PURPOSE
