KNOW ALL MEN BY THESE PRESENTS:

That we, being natural persons of the age of 21 years or more, being desirous of improving public education concerning infectious hepatitis and research and treatment thereof, for the purpose of forming a not-for-profit corporation under and in accordance with the laws of the State of Florida, DO HEREBY CERTIFY:

ARTICLE ONE: The name of the corporation is **SUNCOAST HEPATITIS FOUNDATION, INC.**

ARTICLE TWO: The principal place of business and mailing address of this corporation shall be: Suite A, Rosemary Court, 800 Central Ave., Sarasota, FL 34236

ARTICLE FIVE: The purposes for which the corporation is organized are:

(A). To promote education, research, and treatment of infectious hepatitis and all related activities.

(B). No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, incorporators or any other private persons, except that the corporation shall be allowed to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the preceding Article (A) hereof.

(C). The doing of any and all things necessary and incident to the performance of the purposes above set forth insofar as the same are permissible under the statutes governing this corporation.

ARTICLE FIVE: The duration of the corporation shall be perpetual.

ARTICLE SIX: These Articles of Incorporation may be amended from time to time in the manner provided by law.

ARTICLE SEVEN: The method of electing directors and members shall be as provided in the by-laws.

ARTICLE EIGHT: Membership is not limited or restricted by reason of color, gender, ethnic origin or sexual preference.

ARTICLE NINE: Upon dissolution of the corporation, liquidation or abandonment of its property, assets remaining after the payment of, or provision for the payment of, all liabilities of the corporation, shall be distributed to one or more organizations whose purposes and activities in the opinion of the last directors are consistent with the objectives of public service of this organization.

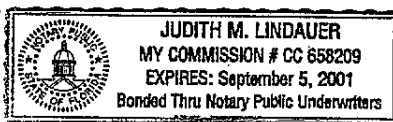


