The undersigned incorporator for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation:

ARTICLE I  
NAME

The name of the corporation shall be: **ADVOCATING DISABILITY RIGHTS, INC.**

ARTICLE II  
PRINCIPAL OFFICE

ARTICLE III  
PURPOSE

The specific purpose for which the corporation is organized is to engage in the advocacy of the need for those individuals and/or entities required to comply with the provisions of the American with Disabilities Act to fulfil their obligation under the American with Disabilities Act so that those persons disabled can have access to all places of public accommodation.
