Article One - Name

THE NAME of this corporation shall be "The Sheng-tua Buddhist Center, Inc."

Article Two - Principal Place of Business

THE PRINCIPAL PLACE of business and the mailing address of the corporation shall be: 10151 University Blvd., #353, Orlando, Florida 32817-4828.

Article Three - Purpose

THE PURPOSES for which The Sheng-tua Buddhist Center, Inc., is organized are exclusively charitable, and it is the purpose of this corporation to provide a forum for the study and sharing of the teachings of Sheng-tua Buddhism as it develops in America. Further, to work for community and global self improvement, peace, harmony and love. Notwithstanding any other provisions of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)3 of the Internal Revenue Code, or the corresponding provision of any future United States Internal Revenue Law.


