**ARTICLES OF INCORPORATION OF  
CITIZENS TO PRESERVE TALLAHASSEE, INC.**

The undersigned Incorporator hereby files these Articles of Incorporation to form a corporation under the laws of the State of Florida.

**ARTICLE I  
Name**

The name of the corporation is **CITIZENS TO PRESERVE TALLAHASSEE, INC.**

**ARTICLE II  
Purpose**

The purpose of the corporation is to further the common good and general welfare of the Leon County, Florida community by promoting better roads, clean water and flood control and protection. The corporation is organized to be a not-for-profit corporation, and may engage only in activities that may be carried on by a corporation exempt from Federal income taxes under Section 501(c)(4) of the Internal Revenue Code or any section of any statute adopted in succession thereof. No part of the net earnings of the corporation shall inure to the benefit of any member, except that the corporation may pay reasonable compensation for services rendered and may make payments or distributions in furtherance of the purposes set forth herein.




