Morant Bay High School Alumni Association - Florida, Inc., a Florida non-profit Corporation under the Florida Not-For-Profit Corporation Act, hereby adopts the following Articles of Incorporation.

Article I

The Name of the Corporation shall be:

Morant Bay High School Alumni Association - Florida, Inc.

Article II

The principal place of business and mailing address of this Corporation shall be:

1961 S.W. 120 Terrace, Miramar, Florida 33025

Article III

The specific purposes for which the Corporation is organized are:

- To perform charitable activities within the meaning of Internal Revenue Code Section 501© and Chapter 496 of the Florida Statute
- Specifically, the Corporation is organized to operate a charitable service for the benefit of the Morant Bay High School Alma Mater, students without the means to satisfy their basic educational needs, and any other activities the corporation deems necessary.
