The undersigned incorporator, for the purpose of forming a corporation under the Fiorida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I.

NAME

The name of the Corporation shall be:

ARTICLE II.

PRINCIPAL OFFICE

ARTICLE III.

PURPOSES

The specific purposes for which the Corporation is organized are:

The purposes of this Corporation are as follows:

- The objectives of this Corporation shall be to sustain, promote, and encourage religious worship, to provide for the preaching of the gospel, to circulate and teach the Bible and other religious literature; to carry on temperance, benevolent, missionary work, to minister unto the sick and afflicted, and lift up the fallen;

This Corporation shall have and exercise all right and powers conferred upon Corporations under the laws of the State of Florida, provided, however, that this Corporation is not in power to engage in any activity that, in itself, is not in furtherance of its purpose as set forth in this provision.
