ARTICLES OF INCORPORATION
OF

THE CHURCH OF CHRIST WRITTEN IN HEAVEN, OF GOULDS,

a Florida Not For Profit Corporation

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I.

NAME

The name of the Corporation shall be:

THE CHURCH OF CHRIST WRITTEN IN HEAVEN, OF GOULDS, FLORIDA, INC.

ARTICLE II.

PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be:
1760 SW 220 Street, Goulds, Florida, 33170.

ARTICLE III.

PURPOSES

The specific purposes for which the Corporation is organized are:

The purposes of this Corporation are as follows:

1. The objectives of this Corporation shall be to sustain, promote, and encourage religious worship, to provide for the preaching of the gospel, to circulate and teach the Bible and other religious literature; to carry on temperance, benevolent, missionary work, to minister unto the sick and afflicted, and lift up the fallen;

2. To ordain Elders, Deacons, and Evangelists, and to appoint Missionaries for the perfection of the saints and the administration of the Lord's Supper and feet

washing as administered by himself. To enforce ordinances enacted by himself and practiced by the Holy Apostle St. John 13th Chapter. Solemnizing matrimony, burying the dead, and a better control of the Church, its affairs and property, to extend charity and stimulate education, to fight vice and wickedness and for the uplifting of mankind.

3. The specific and primary purpose for which this Corporation is organized is to acquire, maintain, construct, improve, provide and furnish real property and/or personal property and/or cash for church and religious purposes as described in Section 501(c)(3) of the Internal Revenue Code of 1986 as amended (hereinafter the "Code").

4. This Corporation shall have the power to receive gifts of real property and/or personal property and/or cash to accomplish the above listed purpose.

5. The Corporation shall operate exclusively in a manner which is consistent with Section 501(c)(3) of the Internal Revenue Code.

6. This Corporation is organized, and shall be operated, exclusively for not-for-profit purposes and no part of any net earnings shall inure to the benefit of any member, director or officer.

7. This Corporation shall have and exercise all right and powers conferred upon Corporations under the laws of the State of Florida, provided, however, that this Corporation is not in power to engage in any activity that, in itself, is not in furtherance of its purpose as set forth in this provision.

ARTICLE IV.

MANNER OF ELECTION OF DIRECTORS

The authorized number, qualification, and manner of election and appointment of members of the Board of Directors to this Corporation, shall be as set forth in the By-Laws of this Corporation.

ARTICLE V.
