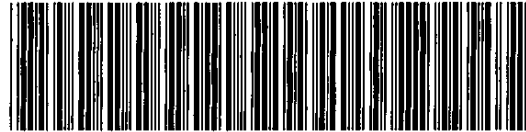

Pursuant to the provisions of section 617.1006, **Florida Statutes**, this **Florida Not For Profit Corporation** adopts the following amendment(s) to its Articles of Incorporation:

ARTICLE IV, SECTION I: Being amended should read as:

General Powers: The legal affairs of the church shall be managed by the pastor/president and the majority of the Board of Directors. The Ecclesiastical affairs of the church shall be managed by the pastor/president and his appointees.

ARTICLE V, SECTION 6 (d): Being amended should read:

Treasurer is responsible to oversee an accurate account and receipt of disbursements in books belonging to the church are maintained and ensure that all monies; and other valuable effects in the name and to the credit of the church in such banks and depositories as may be designated by the Board of

ARTICLE V, SECTION 6 (d) Continued:

Directors, but shall not be personally liable for the safekeeping of any funds, or securities so deposited pursuant to the order of the Board. He shall disburse the funds of the church as may be ordered by the Board and shall render to the pastor-president and Directors at the regular meeting of the Board, and whenever they may require, accounts of all his transactions as treasurer and of the financial condition of the church. He shall perform the duties usually incident to the office of treasurer and such other duties as may be prescribed by the Board of Directors or by the pastor-president.

ARTICLE IV SECTION 2 Number, Term and Qualifications (addition to last paragraph): Being amended as:

The number of Directors shall be no less than three (3) and shall have no maximum number. The term of membership shall be for a one (1) year period, except for the pastor -president [see ARTICLE FIVE, section 6 (a)]. Those set forth in the Articles of Incorporation shall comprise the original Board of Directors. Any member of the Board of Directors must also be a member of the congregation of the church. They must also be faithful in tithing and church attendance; and must also be accountable to pastor-president.
