I am an officer of two non profit corporations which were administratively dissolved due to failure to file the Annual Report. Each was permitted to refile late and was restored. On October 14, 2003 we filed for reinstatement of St. Lucie Community Development Corporation the document number of which is N98000003653. That company was restored, and information entered on your web site records with our new address and new officers.

Subsequently, on October 29, 2003 we similiarly applied to reinstate Central Florida Non Profit Housing, Inc., the Document number of which is N00000004625. By oversight, we unfortunately used the earlier computer form letter and did not change the number. As you can see from the enclosed Annual Report it mistakenly references the document number N98000003653. That is the Document Number of St. Lucie Community Development Corporation.

As a consequence you recorded the information applicable to Central Florida Non Profit Housing Inc. to St. Lucie Community Development Corporation. Worse yet, no change was entered as to Central Florida Non Profit Housing, Inc., which consequently remains recorded on your records as administratively dissolved
