Articles of Incorporation

In compliance with Chapter 617, F.S. (Not for Profit)

Article I. NAME

The name of the corporation shall be the Scott Michael Ogden Memorial Debate Fund, Inc. (hereinafter "the corporation.")

Article II. PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation shall be 2925 Boxwood Court, Palm Harbor, FL 34684

Article III. PURPOSE

The purposes of the corporation shall be to:

- A. raise funds, primarily from the general public as a public charity,
- B. conserve these funds in interest-bearing financial instruments under terms to be set by the directors,
- C. support the study and practice of forensic debate in public and private schools and universities through methods including but not limited to
 - 1. awarding scholarships to students who have participated in and shown a commitment to forensic debate and who meet certain academic criteria, provided that no such criteria relate to race, creed, color, sex or other protected minority status
 - 2. providing awards including cash awards to students who succeed in forensic debate competitions
 - 3. paying expenses for forensic debate classes, seminars, workshops, competitions and other events when sponsored by public and private schools and universities or by recognized forensic debate associations or clubs, or by other organizations interested in supporting the study and practice of forensic debate,
 - 4. disseminating information about the study and practice of forensic debate,
- D. cooperate with other organizations, both private and public, for profit and not

for profit, for the purpose of supporting and advancing the study and practice of forensic debate,

E. operate primarily within the states of Florida and New York.

Article IV. MANNER OF ELECTION

The number of directors and the manner of election shall be provided for in the bylaws.

Article V. INITIAL REGISTERED AGENT

The initial registered agent is Karen L. Ogden, 2925 Boxwood Court, Palm Harbor, FL 34684

ARTICLE VI. INCORPORATOR
