

In compliance with the requirements of Florida Statute Chapter 617, the undersigned, being natural persons, hereby act as incorporators in adopting and filing these Articles of Incorporation for the purpose of organizing a corporation not for profit.

**ARTICLE I**

The name of the corporation is: The Committee for the Support of The Center for Catholic & Jewish Studies, Inc.

**ARTICLE II**

**ARTICLE III**

**ARTICLE IV**

The specific and primary purposes for which this corporation is formed are:

- A. The support of the educational, informational and research programs and activities of The Center for Catholic & Jewish Studies of Saint Leo University, a collaboration of the American Jewish Committee and Saint Leo University, to develop mutual respect and understanding between Catholics and Jews and to foster dialogue between the two spiritual traditions.

- B. To host seminars, conferences, lectures and educational courses, to issue publications, and to conduct fund-raising and other educational activities.
- C. To operate exclusively in any other manner for such charitable and educational purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954, as amended, or under any corresponding provisions of any subsequent federal tax laws, covering the distributions to organizations qualified as tax exempt organizations under the Internal Revenue Code, as amended, including private foundations and private operating foundations.


