ARTICLE IV  
MANNER OF ELECTION

1. An initial Board of Directors shall be appointed by the Chairperson for a term not to exceed a maximum of four (4) years. Positions on the Board of Directors shall be rotated off in two-year increments. There is no limit to the number of terms a person may serve on the Board of Directors. However, no person may serve on the Board of Directors for more than five (5) consecutive terms.
2. The initial Board of Directors shall be appointed by the Chairman of the corporation and serve for a specified term not to exceed four (4) years. Subsequent Board members shall be nominated and elected to serve on the Board. The Board may designate one or more directors as alternate members of any committee, who may replace any absent or disqualified member at any meeting of the committee. In the absence or disqualification of a member of a committee, the member or members thereof present at any meeting and not disqualified from voting, whether or not he, she or they constitute a quorum, may unanimously appoint another director to act at the meeting in the place of any such absent or disqualified member. Each committee of the Board shall serve at the pleasure of the Board.

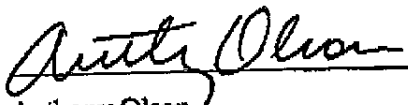

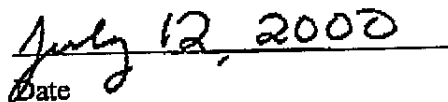
