# Articles of Incorporation

*The undersigned Incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopt the following Articles of Incorporation:*

### Article I-NAME

The name of the corporation shall be Physically Challenged Sports Foundation, Inc.

### Article III-PLACE OF BUSINESS

The principal place of business and mailing address of this corporation shall be 14052 Lake Tilden Blvd., Winter Garden, Florida 34787.

### Article III-DURATION

This Corporation shall exist perpetually commencing on the date these ARTICLES are filed.

### Article IV-PURPOSE

The Physically Challenged Sports Foundation is an organization dedicated to help spread the word to disabled persons as to what type of extra-curricular activities are available to them. We also distribute money to other organizations who cater to the physically challenged and to individual athletes on an as-needed basis.

We accept in-kind as well as monetary donations. A board who reviews requests as they are received distributes funds or in-kind materials.

It is our feeling that rather than "banging" on corporate doors for each organization, fund raising would be better served by accepting a single donation then distribute it among the groups that need it. This creates a better atmosphere for fund raising as the donating person or company will not be bothered constantly by multiple organizations trying to solicit funds.

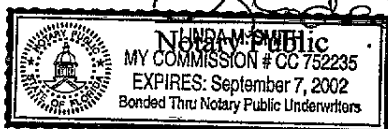
