of

ONE: The name and address of this principal corporation is The New Jerusalem Fellowship of Holiness Center, Inc. 6025 NW 6th Court Miami, Florida 33127 in Miami-Dade County. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO: This corporation is a non-profit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for Religious purposes. To establish structured support service for Evangelistic, Prayer, Missions, Economic Development and Other Ministries to support the outreach Ministries for the Body of Jesus Christ (The Church). The programs will consist of but shall not be limited to: Homelessness, Shelter, Training Programs, Setting up of ministries, Counseling, Job Training, Job Placement, Land Acquisition, Youth, Women and Men Programs, Counseling, and other programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members
