The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLES OF INCORPORATION

ARTICLE I

The name of the corporation is New Level Gospel Music & Books, Incorporated. The corporation may also be known by a contractual form of the above style, and may be represented by expanded or contractual forms to the public, to wit: New Level Gospel Music & Books, Incorporated.

ARTICLE II

The registered office and principal place of this corporation is located at 869 Derbyshire Road Daytona Beach, FL 32117. Offices may also be maintained at such other place or places, either within or without the State of Florida, as may be designated from time to time by the Board of Directors. Bishop Derek T. Triplett of 448 Pelican Bay Drive, Daytona Beach, FL 32119 serves as the President and CEO and Incorporator of this entity.

ARTICLE III

The purpose of this corporation is to proclaim the Gospel of the Lord Jesus Christ, and to otherwise function as a Christian Bookstore.

ARTICLE IV

The corporation elects to have no members. Any actions which would otherwise require a vote of members shall require only a vote of the members of the Board of Directors, and no meeting or vote of members shall be required for this corporation, any provision of the Articles of Incorporation of this Corporation or the By-Laws of the Corporation to the contrary notwithstanding.

The corporation, a ministry, elects the ecclesiastical form of church government, whereby the Board of Directors shall be the highest ecclesiastical tribunal of the organization, and shall be the final arbiter of all questions of doctrine, discipline, property, policy, and policy of every kind and nature whatsoever, and the Board of Directors in its deliberations as the ecclesiastical government of the organization shall use as its sole and final authority and standard the Holy Scriptures Old and New Testaments, King James version.

The manner in which the Board of Directors is elected or appointed is by nomination among the team of original founders, organizers, and volunteers. All subsequent nominations will be by designation of the existing Board of Directors and all nominees will be selected based upon an established set of qualifications and criteria.
