ARTICLES OF INCORPORATION - AMENDED

ARTICLE I

The name of the corporation is New Level Gospel Music and Books, Incorporated. The corporation may also be know by a contractual form of the above style, and may be represented by expanded or contractual forms to the public, to wit: New Level Gospel Music & Books, Incorporated.

ARTICLE II

The registered office and principal place of this corporation is located at 869 Derbyshire Road, Daytona Beach, FL 32117. Offices may also be maintained at such other place or places, either within or without the State of Florida, as may be designated from time to time by the Board of Directors. Bishop Derek T.
