The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I

The corporation shall be named QCF MINISTRIES, Inc.

ARTICLE II

The principal place of business and mailing address of this corporation shall be: 105 ANDERSON AVENUE, SANFORD, FLORIDA 32771

ARTICLE III

The purposes for which the **QCF MINISTRIES, Inc.** is organized are exclusively religious, charitable, literary, and educational within the meaning of section 501©(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501©3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE IV

The directors of the corporation shall be appointed by the President and ratified by the Board of Directors.

ARTICLE V

ARTICLE VII

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, Any salaries, wages, together with fringe benefits or other forms of compensation (housing, transportation and other allowances) paid to or provided any employees, directors or officers will not exceed a value which is reasonable and commensurate with the duties and working hours associated with such employment and with the compensation ordinarily paid persons with similar positions or duties.

ARTICLE VIII

Upon the dissolution of the corporation, the residual assets of the organization will be distributed to one or more organizations which themselves are exempt as organizations described in section 501©3 and 170©2 of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to a State or local government for a public purpose.
