

ARTICLES OF INCORPORATION
of
TRANSFORMATIONAL RESEARCH ASSOCIATION, INC.

ARTICLE I
NAME

The name of the corporation shall be: Transformational Research Association, Inc.

ARTICLE II
PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 17038 West Dixie Highway, North Miami Beach, FL 33160.

ARTICLE III
PURPOSE

The specific purpose for which the corporation is organized is to further the advancement of new and more effective means to promote the health and well being of those suffering from ailments, maladies, and other disturbances related to the presence of toxic and other foreign materials in the body. This purpose extends to developing more effective methods and technologies of supporting and optimizing the natural function and operation of the various organs, tissues and other parts of the human body.

ARTICLE IV
