Articles of Incorporation  
Of  
The Love Sanctuary, Inc.

*The undersigned Incorporator for the purpose of forming  
a corporation under the Florida Not for Profit Corporation  
Act, hereby adopts the following Articles of Incorporation:*

**Article I**

The Name of the Corporation shall be The Love Sanctuary, Inc.

**Article II**

The period of duration of the corporation shall be perpetual.

**Article III**

The purpose for which this corporation is organized is to be a Church to share Christ through his spoken word, and to spread the gospel in outreach ministries. To do everything necessary, proper, advisable, or convenient for the accomplishment of said purposes, and to do all other things incidental to them; or connected with them that are not forbidden by the Florida Corporation Laws or by other law, or by these Articles of Incorporation and to carry out the said purposes in any state, territory, district, or possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the land, the state, territory, district, or possession of the United States or by the foreign country.

**Article IV**

The Initial street address for the Registered office of the corporation is: 750 South Orange Blossom Tr. Suite 267, Orlando, FL 32805. The Name of the Registered Agent at such address is: Ozzle Mason.

**Article V**

The Initial Board of Directors shall consist of three (3) members, who need not be residents of the State of Florida or Shareholders of the corporation.

The Directors shall be members of the local church and shall satisfy the scriptural standards for church leadership.

A meeting will be held on the first Sunday evening in December of each year. Directors will be elected, received and affirmed by congregational vote.

**Article VI**

And hold office until resignation or termination by the board of directors.
