Pursuant to the provision of the Nonprofit Corporation Act of this state, the undersigned Incorporator hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

To develop a multimedia production corporation to teach and disseminate religious and educational material to the public, including, but not limited to, materials relating to International Seventh-Day Adventist programming, through radio, video, television, cable access television or otherwise.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. [this is a statement of tax exempt purposes required under IRC Section 501(c)(3)]

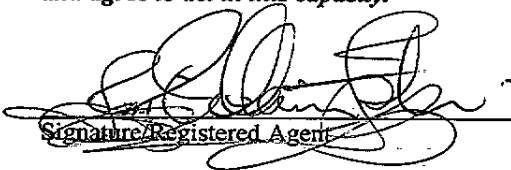
Additional provisions:

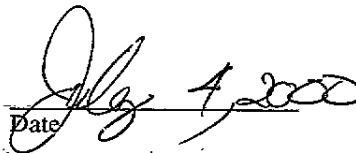
Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, for all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose. [this is the dedication of assets statement required under IRC Section 501 (c) (3)]

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation [except as otherwise provided by Section 501 (h) of the Internal Revenue Code], and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office. [this is the optional limitation on political activities statement under IRC Section 501 (c) (3)]

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c) (2) of the Internal Revenue Code. [this is the optional general limitation on activities statement under IRC Section 501 (c) (3)]
