ARTICLE I

NAME

The name of this not for profit corporation shall be: NAWBO of Southwest Florida, Inc.

ARTICLE II

PRINCIPAL OFFICE

The principal office of the corporation shall be 6450 Pine Avenue, Sanibel, Florida 33957 or any other location within Southwest Florida as may be approved by the Board of Directors. The mailing address of this corporation shall be 4600 C-2 Summerlin Road, #575, Fort Myers, Florida 33919 or any other location within Southwest Florida as may be approved by the Board of Directors.

ARTICLE III

MEMBERSHIP

Any person, meeting the eligibility for membership requirements as set forth in the By-Laws, may become a member of this not for profit corporation upon payment of such dues as are set by the directors of the corporation from time to time. There shall be two classes of members: voting and nonvoting with such other eligibility requirements, rights and privileges as are set forth in the By-Laws.

ARTICLE IV

PURPOSE and POWERS

Section 1: The primary purposes of this not for profit corporation are to encourage ownership by women in business; to encourage and support women who own

and operate businesses; to provide a voice for women who own and operate businesses; and to foster the economic stability of business owned and operated by women.

Section 2: This not for profit corporation shall have the power to exercise all rights, privileges and powers, and have the benefit of all immunities as may be given to or enjoyed by not for profit corporations organized under the Florida Not For Profit Corporation Act and as are permitted for a corporation qualifying as a 501(c) (6) organization under the Internal Revenue Code of 1986, as amended from time to time.

Section 1: The board of directors shall consist of the President, President-elect, three vice presidents, Secretary, Treasurer, the Immediate Past President, and at least one and up to four (4) directors at large as determined by the board of directors from time to time.

Section 2: The directors shall be appointed or elected in the manner and for the terms specified in the bylaws and shall meet the eligibility standards set forth in the By-Laws.
