ARTICLE II - TERM

THIS CORPORATION PRESIDENT, WHO WILL BE PASTOR OF "ELOHIM MINISTRIES PRAISE & WORSHIP CENTER, INC.) THE OFFICES OF VICE PRESIDENT, SECRETARY, TREASURER AND SUCH OTHER OFFICES AS MAY BE NECESSARY SHALL BE FILLED BY AN ELECTED VOTE OF THREE FIFTHS (3/5) OF THE MAJORITY OF THE CORPORATION PRESENT AT ANY BUSINESS MEETING, AND FOR SUCH TERM AS THE CORPORATION MAY PROVIDE IN IT'S BY-LAWS.

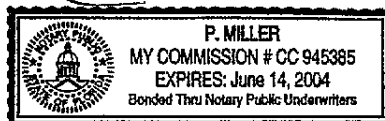
