ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)
OF
COMMUNITY PERFORMING ARTS FOUNDATION CORP.

ARTICLE I - NAME

The name of the corporation shall be Community Performing Arts Foundation Corp.

ARTICLE II - PRINCIPAL OFFICE


ARTICLE VIII - AMENDMENT
