(A NON-PROFIT CORPORATION)

The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statues, adopt(s) the following Articles of incorporation:

### ARTICLE I: NAME

The name of the corporation shall be:

## ARTICLE III: PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

Said corporation is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Sectiob 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law). No part of the net earning of the corporation shall leave to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in [these articles]. No substantial part of the actvities of the corporation shall be the carring on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Interal Revenue Code of 1954 (or the corresponding provision of any further United States Interal Law); or (b) by a corporation contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision for ant future United States Internal Revenue Law).
