ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be W.A.M.E., Inc.

ARTICLE II-PRINCIPAL ADDRESS OF PRINCIPAL OFFICE

ARTICLE III- PURPOSE

The purpose of this corporation is to develop, and to promote programs that foster educational enhancement, community awareness, health care and economic empowerment. To contract or be contracted with for the above expressed purposes. To do all acts necessary or expedient for the administration of the affairs and attainment of the purpose of this corporation. To operate as a charitable, scientific, literary, and educational organization within the meaning of section 501C(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Upon dissolution of the corporation, assets shall be distributed to one or more exempt purposes within the meaning of section 501C(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall distribute to the federal government, or to a state and local government for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the incorporation is then located, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IV- MANNER OF ELECTION

The board of directors shall be appointed by the Incorporator/President of the Corporation and shall serve for a term of one year.
