ARTICLES OF INCORPORATION

All State Control of the State STRATEGIC TRAFFIC SCHOOL, INC.

PREAMBLE

I, the undersigned being of legal age and a natural person, in order to form a non-profit corporation under the laws of the State of Florida, adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be Strategic Traffic School, Inc. The principal place of business and mailing address of this corporation shall be located at 501 Goodlette Road North D100 Suite 9, Naples, Florida 34102.

ARTICLE II OBJECT AND PURPOSE

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The specific purposes for which this corporation are organized are to provide educational services and related support services to members of the local community at a reasonable cost. The corporation will help clients complete the necessary requirements of court and state ordered DUI and traffic schools and also provide educational opportunities to all members of the local communuity to help them improve their driving skills.

In the event of dissolution of this Corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the Corporation, distribute all remaining assets for one or more exempt purposes as specified within Section 501(c)(3) of the Internal Revenue Code or these assets shall be distributed to the federal government, or to a state or local government, for a public purpose.

ARTICLE IV INITIAL REGISTERED AGENT AND ADDRESS

The name of the initial registered agent of this Corporation is Patricia Bilitzke. The address of the initial registered agent is 6118 Thresher Drive, Naples, Florida 34112.

ARTICLE V - INCORPORATOR

The name of the incorporator to these Articles of Incorporation is Patricia Bilitzke. The address of the incorporator is 6118 Thresher Drive, Naples, Florida 34112.

ARTICLE VI - INITIAL DIRECTORS

The property, business and affairs of this Corporation shall be managed by a Board of Directors which shall initially consist of three members. If the number of Directors determined as provided above shall ever be less than two, the remaining directors shall appoint temporary Directors to act in such a capacity until the number of members shall at least equal two. The period of the duration of this corporation is perpetual.

ARTICLE VIII - MEMBERS

This corporation shall have no members.

ARTICLE IX - LIMITATION ON PRIVATE INUREMENT

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

ARTICLE X - GENERAL LIMITATION ON ACTIVITIES

Not withstanding any other provisions of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)3 of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section (170)(c)(2) of the Internal Revenue Code.
