ARTICLES OF INCORPORATION OF LYNN LINGENFELTER FOUNDATION, INC.

The undersigned, acting as incorporator of a corporation not for profit pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I - Name.

ARTICLE III - Purposes

The specific purposes for which the corporation is organized are for

- (A) To support religious, charitable and/or educational organizations and works as may further be identified herein. (B) To support those charitable interests and organizations that were and are the specific concerns of Lynn Lingenfelter (C) To communicate the gospel of Jesus Christ through the words and actions of its trustee/members.

(E) To advance religious, charitable, educational, and any other related or corresponding charitable purpose, including distribution of its funds for such purposes to organizations that qualify as exempt organization under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any subsequent United States Revenue Law)

The general purposes for which this corporation is formed are: To operate exclusively for such religious, charitable and/or educational purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code, 1954, or corresponding provisions of any subsequent federal tax laws, including, for such provisions, the mailing of distributions to organizations which qualify as tax exempt organization under the Code, as aforesaid.
