The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

## ARTICLE I: NAME

The name of the corporation is **Iglesia Missionera, Inc.**

## ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is **P.O. Box 944 (274 Center St (US-17)), Pierson, FL 32180.**

## ARTICLE III: PURPOSE

## ARTICLE IV: QUALIFICATION
