## ARTICLES OF INCORPORATION

The undersigned incorporator to these Articles of Incorporation, hereby forms a Not For Profit Corporation for profit pursuant to the Corporations Act and other laws of the State of Florida.

### ARTICLE I NAME

### ARTICLE III CORPORATE PURPOSE

The Corporation will not substantially engage in activities that are not related to furthering the charitable purposes for which the Corporation was formed, or bestow special benefits on particular individuals rather than the public at large.

### ARTICLE IV MANNER OF APPOINTMENT OF DIRECTORS

The Directors of the Corporation shall be appointed in the manner set forth in the by-laws of the Corporation.

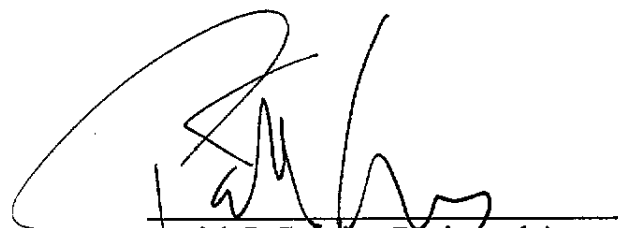
