The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

**ARTICLE I**  
**NAME**

*The name of the corporation is*  
*CHRISTIAN RADIO NETWORK, INC.*

The principal office is 25 Beverly Court, Homosassa, Florida 34446.

**ARTICLE II**  
**PURPOSES AND OBJECTIVES**

This Corporation is organized for the following purposes and objectives:

1: To obtain a license from the Federal Communications Commission (FCC) for a Low Power FM broadcasting station for the purpose of creating a community based radio station for the purpose of religious programing.

2: To build, own and operate a radio station that will provide, educational programing, entertainment and music of a Christian nature.

**ARTICLE III**  
**CORPORATE POWERS**

Christian Radio Network, Inc. shall have all of the powers granted to corporations not for profit under the laws of the State of Florida as they now exist and as they may be increased by said laws in the future.

**ARTICLE IV**  
**MEMBERSHIP**

This corporation shall consist of not less than three (3) members. A member must be willing to take an active part in the operation of the corporation. A members must also demonstrate through their lifestyle, a practice to the Christian faith.

**ARTICLE XIII**  
**DISSOLUTION**

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which are themselves exempt as organizations described in section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or the Federal, State, or Local government for exclusive public purpose.

**ARTICLE XV**  
**ACTIVITIES TO COMPLY WITH INTERNAL REVENUE CODE**

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by:

(1) a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law or,

(2) a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 or any other corresponding provision of any future United States Internal Revenue Law.
