Pursuant to the provision of the Nonprofit Corporation Act of The state of Florida. The undersigned incorporators hereby adopt the following Articles of Incorporation:

ARTICLE 1

The name of this corporation is: CHINA FREE TRADE ASSOCIATION, INC

ARTICLE 2

The name and address of the registered agent and registered office of this corporation is:

ARTICLE 3

The purposes for which this corporation is organized are: To establish a Charitable Organization to build strategic alliances with manufacturers to receive contributions and to distribute to the various not-for-profit groups funding to aid the beneficiaries of these not-for-profit organizations. CHINA FREE TRADE Association, will function as a Trade Association, sponsors selected developers, manufacturers and distributors of products and receive charitable funding for distributions to not-for-profit organizations engaged in promoting Asian-American trade and commerce, media publishing, and health care projects.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes the making of distributions to organizations that qualify, as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or Corresponding section of any future federal tax code.

ARTICLE 7

The classes, rights, privileges, qualifications, and obligations of members of this corporation are as follows:

As stated in the Bylaws of this corporation

ARTICLE 8

Upon the dissolution of this corporation, its assets remaining after payment, payment, of all debts and liabilities of this corporation shall be one or more exempt purposes within the meaning of Section Internal Revenue Code or shall be distributed to the Federal or to a state or local government, for a public purpose.

No substantial part of the activities of this corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation [except as otherwise provided by Section 501(h) of the Internal Revenue Code], and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable Compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.
