**ARTICLES OF INCORPORATION
OF
GROUND ZERO, INC. OF JACKSONVILLE**

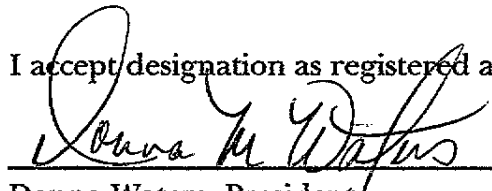
ONE: The name and address of this principal corporation is Ground Zero, Inc. of Jacksonville located at 8049 Helston Drive - Jacksonville, Florida 32208, in Duval County. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, charitable and educational purposes to aid the poor and disadvantaged individuals and families toward a life of self-sufficiency. The programs will consist of but shall not be limited to: Twenty Four Hour Gym, Health Education, Physical Fitness, Weight Training, Personal Trainers, Teen Job Placement, Land Acquisition, Counseling, Basketball Tournaments, Tutoring, Summer Camp, Before & After School Care, Community Employment, Leadership Training, Computer Labs, Seminars, Health Fairs, Track and Field, Massage therapy, Aids/HIV Education, Drug Awareness, and other programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.

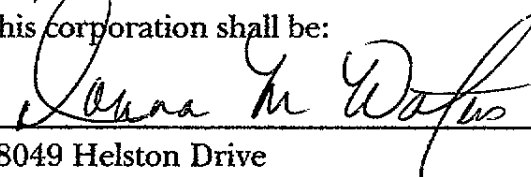
