Pursuant to the provisions of Section 617.1105, Florida Statutes, the undersigned have adopted and executed these Articles of Merger which provide that:

- 1. First Baptist Church of Coconut Creek, Inc., a Florida not-for-profit corporation, shall be merged with and into New Life Community Church of Broward County, Inc., a Florida not-for-profit corporation.
- 2. New Life Community Church of Broward County, Inc. shall be the surviving corporation.
- 3. The Plan of Merger, dated October 29, 2000, is attached hereto and made a part hereof.
- 4. There are no members entitled to vote on the Plan of Merger. The Plan of Merger, pursuant to which First Baptist Church of Coconut Creek, Inc. shall be merged into New Life Community Church of Broward County, Inc. was adopted and approved at a meeting of the board of directors of New Life Community Church of Broward County, Inc. on October 29, 2000; the number of votes cast for the merger was sufficient for approval, and the vote for the Plan of Merger was unanimous.
- 5. There are no members entitled to vote on the Plan of Merger. #### PLAN OF MERGER

This Plan of Merger is dated this 29th day of October, 2000, for the merger of FIRST BAPTIST CHURCH OF COCONUT CREEK, INC., a Florida not-for-profit corporation, into NEW LIFE COMMUNITY CHURCH OF BROWARD COUNTY, INC., a Florida not-for-profit corporation. NEW LIFE COMMUNITY CHURCH OF BROWARD COUNTY, INC. is to be the Surviving Corporation.

This Plan of Merger is submitted in compliance with Section 617.1101, Florida Statutes.

- 1. First Baptist Church of Coconut Creek, Inc. is a Florida not-for-profit corporation.
- 2. New Life Community Church of Broward County, Inc. is a Florida not-for-profit corporation.
- 3. In accordance with the provisions of this Plan of Merger, at the Effective Time (as defined below), First Baptist Church of Coconut Creek, Inc. shall be merged into New Life Community Church of Broward County, Inc. (the "Merger") and the separate corporate existence of First Baptist Church of Coconut Creek, Inc. shall cease and New Life Community Church of Broward County, Inc. (the "Surviving Corporation") shall continue its corporate existence pursuant to the laws of Florida. First Baptist Church of Coconut Creek, Inc. and New Life Community Church of Broward County, Inc. are herein collectively referred to as the "Constituent Corporations".)
- 4. The Merger shall become effective on the date the Articles of Merger are filed with the Florida Department of State (the "Effective Time").
- 5. The Surviving Corporation shall possess and retain every interest in all assets and property of every description of each of the Constituent Corporations. The rights, privileges and immunities, powers, franchises and authority; of a public as well as of a private nature of each of the Constituent Corporations shall be vested in the Surviving Corporation without further act or deed. The title to and any interest in all real and personal property vested in any of the Constituent Corporations shall not revert or in any way be impaired by reason of the Merger.
- 6. All obligations belonging to or due to each of the Constituent Corporations shall be vested in the Surviving Corporation without further act or deed, and the Surviving Corporation shall be liable for all obligations of each of the Constituent Corporations existing as of the Effective Time.
- 7. The Articles of Incorporation of New Life Community Church of Broward County, Inc. in effect immediately prior to the Effective Time shall continue without change and be the Articles of Incorporation of the Surviving Corporation.
