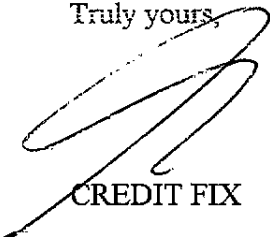

of

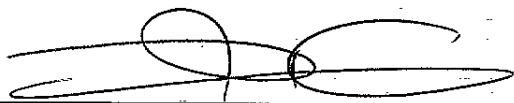
