ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I Name

The name of the corporation shall be:

ARTICLE II Principal Place of Business

ARTICLE III Purpose(s)

The specific purpose(s) for which the corporation is organized is (are):

Grace Community Baptist Church Belief Statement

God tells us in Matthew 28:19-20 to go and make disciples of all nations baptizing them in the name of the Father and of the Son and of the Holy Spirit, teaching them to obey everything He has commanded us. As we do this, God has promised to always be with us.

God also tells us in Acts 2:36-47 what a church should be. We are charged in Acts 2:36-41 to be evangelistic. We are charged in Acts 2:42 to worship and to involve ourselves in teaching and studying God's Word. We are charged in Acts 2:44-47 to be of one accord, immersing ourselves in like-minded Christian fellowship, praising God and finding favor with all people. Acts 2:42 also charges us to be praying Christians.

We commit to be a body of believers of like mind and spirit, fellowshiping together through worshipping God with awe and reverence. We commit to be in constant prayer both as individual believers and as a cooperate body of believers. With this mission and purpose established and in action, God will fulfill His promise of Acts 2:47 by adding to our numbers daily those who are being saved.

Mission Statement

To reach the lost and hurting of our community with the love of God that is available through Jesus Christ.

Vision Statement

To establish a true New Testament Church where Jesus Christ, the One and only true and living Lord, is lifted-up high and exalted.

ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

Directors will be nominated from the church body and approved or accepted by an 80% majority vote of the established membership present at the annual meeting. All business actions of the corporation must be approved by an approval vote of 80% of the members present at business meetings unless otherwise specified in the by-laws.

ARTICLE V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

Any limitation or extension of the powers of this corporation other than those stated in F.S. 617.0302 must be approved by an approval vote of 80% of the members present at business meetings scheduled for this purpose.



