ARTICLES OF INCORPORATION

of

MIAMI BUSINESS FORUM, INC. (A Florida Not-For-Profit Corporation) SEGRETARY OF STATE DIVISION OF CORPORATIONS

Article I. NAME

The name of this corporation shall be MIAMI BUSINESS FORUM, INC. (hereinafter called the "Corporation").

Article II. PRINCIPAL OFFICE AND/OR MAILING ADDRESS

The address of the principal office and/or the mailing address of the Corporation is 1221 Brickell Avenue, Miami, Florida 33131.

Article III. PURPOSE

This Corporation is a not-for-profit corporation, organized for the promotion of social welfare as defined in Section 501(c)(4) of the Internal Revenue Code of 1986, as amended, including, without limitation, to enhance the civic life in Greater Miami and support discussions and meetings to facilitate involvement in civic affairs, and for the purpose of engaging in any lawful act or activity not for pecuniary profit for which not-for-profit corporations may be organized, so far as is or may be permitted by the laws of the State of Florida and Section 501(c)(4) of the Internal Revenue Code of 1986, as amended.

Article IV. MEMBERSHIP

Persons shall be admitted as members of the Corporation in accordance with the provisions of the Bylaws of the Corporation.

Article V. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Corporation is 103 N. Meridian Street, Lower Level, Tallahassee, FL 32301; and the name of the Corporation's initial registered agent at that address is Corpdirect Agents.

Article VI. BOARD OF DIRECTORS

The affairs of this Corporation shall be managed by a Board of Directors consisting of no less than three (3) directors. The number of directors may be increased or decreased from time to time, in accordance with the Bylaws of the Corporation, but shall never be less than three. The manner of election of directors shall be regulated by the Bylaws.

Upon the dissolution or winding up of this Corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the Corporation, shall be distributed to a not-for-profit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax except status under Sections 501(c)(3) or (c)(4) of the Internal Revenue Code of 1986, as amended, or corresponding provisions of any subsequent federal tax laws.

Article IX. LIMITATIONS

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its directors, officers, members or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(4) of the Internal Revenue Code of 1986, as amended
