The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. Name. The corporate name that satisfies the requirements of Section 617.0401 is: Checkers Advertising Cooperative Association of Puerto Rico, Inc.

ARTICLE II. Principal Office. The principal place of business and the mailing address of this corporation is:

ARTICLE III. Purpose. The specific purpose for which the corporation is organized is to promote and further the interests of the operators of Checkers Restaurants in the Bayamon area, Territory of Puerto Rico, through broadcast and other media.


