ARTICLE ONE-NAME

The name of this corporation shall be: **NEW BEGINNING CHRISTIAN METHODIST EPISPOCAL CHURCH, INC.**, A Religious Corporation.

ARTICLE TWO-PRINCIPAL OFFICE

ARTICLE THREE-PURPOSE

The general purpose of **NEW BEGINNING CHRISTIAN METHODIST EPISPOCAL CHURCH, INC.**, hereinafter referred to as the Church, shall be establish and maintain a place for the worship of the Almighty God. The Christian Methodist Episcopal Church cherishes its place in the universal church which is the body of Christ and is devoted to acceptance of the Apostolic faith. Therefore, all persons without regard to race, color, national origin, or economic condition shall be eligible to attend its worship services, to participate in its program and when they take the appropriate vows to be admitted into it's membership in any local church in the Christian Methodist Episcopal (C.M.E.) Connection.

Membership in this Church shall be eligible to all those persons who offer themselves for Church membership, let the Preacher in charge inquire into their spiritual condition and receive them into the Church when they have given satisfactory assurances of their desires to flee from the wrath to come and to be saved from their sins; also of the genuineness of their faith, and of their willingness to keep the rules of the Church. When satisfied on these points, the Minster shall bring the candidates before the Congregation, whenever practicable, and receive them according to the prescribed form. If a member in good standing in any other church shall desire to unite with us, such applicant may, by giving satisfactory answers to the usual inquires, be received without these formalities.

**ARTICLE FOUR-MANNER OF ELECTION OF
OFFICERS/TRUSTEES/DIRECTORS**

The manner in which the Trustees are elected or appointed is: The affairs of this corporation shall be managed by a Board of Trustees composed of four persons and the following officers: President, Secretary and Treasurer. The pastor of the Church, or Minister in Charge, shall be the President of the corporation. The Trustees, Officers, Pastor or minister in Charge, shall be elected or appointed in accordance with the Doctrines and Discipline of the Christian Methodist Episcopal Church.

ARTICLE FIVE-OFFICERS/TRUSTEES LISTED AS FOLLOWED

There shall be a Board of trustees of the Christian Methodist Episcopal Church elected according to the Discipline, who shall hold title to all property, real, personal, or mixed, belonging to the Connection. The Officers and Board of Trustees who will manage the business of this corporation until the first election of appointment as provided by the Doctrines and Discipline of the Christian Methodist Episcopal Church or until their successors are elected and qualified.

ARTICLE SIX-PROPERTY

The Corporation shall have the power to acquire and hold title in fee simple, in trust, or otherwise, to both real and personal property, and to improve, sell, convey and dispose of all such property in conformity with the Discipline of the Christian Methodist Episcopal Church.

ARTICLE SEVEN-BY LAWS

The by-laws of this corporation shall be the Discipline of the Christian Methodist Episcopal Church as from time to time enacted, authorized and declared by its General Conference. Additional by-laws may be adopted by the church which are not inconsistent with or changed by a majority vote of the membership at the Quarterly Conference of the Church who are in attendance at any regular or special business meeting of the Church.

ARTICLE EIGHT-ADMENDMENTS OR CHANGES

These Articles of Incorporation may be amended be or changed by a majority vote of the Quarterly Conference of the Church who are in attendance at any regular or special meeting called for that purpose.
