We received a UBR for Alvin A & Norma L. Gould Charitable Foundation. A copy of which is enclosed. On this UBR the FEI number was not enclosed. You sent it back and we resubmitted the same approximately within five (5) days, a copy with the UBR with the EIN number written in is enclosed for your benefit.
